# The challenge

## Complexity and risks in the management of benefits

Employee benefits are an important part of staff retention. However, the correct recording and evaluation of these benefits poses considerable challenges for many companies, such as

### 1. Complete recording

The comprehensive documentation of all benefits for employees and third parties requires a great deal of organizational effort.

### 4. Effort and costs

Complete recording often means a great deal of effort and high costs for the payroll and tax departments.

### 2. Tax and social security compliance\*

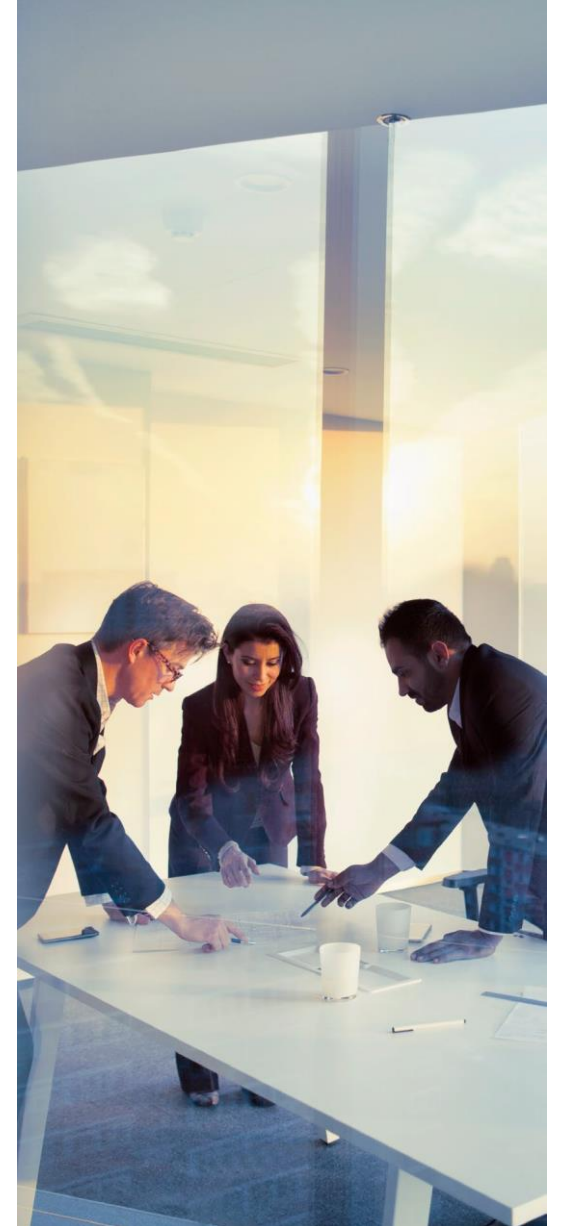
The regulations in the area of benefits are complex due to the large number and heterogeneity of wage tax, value-added tax (VAT) and corporate income tax (CIT) regulations as well as social insurance law and require detailed knowledge of the relevant regulations.

### 5. Risks:

Non-compliance can result in high additional tax payments and penalties.

### 3. Regulatory compliance

Compliance with and documentation of German tax regulations, in particular the monthly exemption limits, is often difficult to ensure.

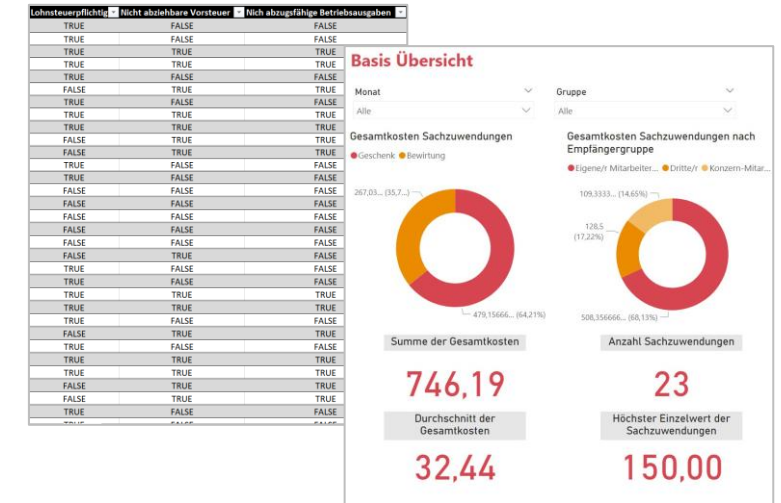
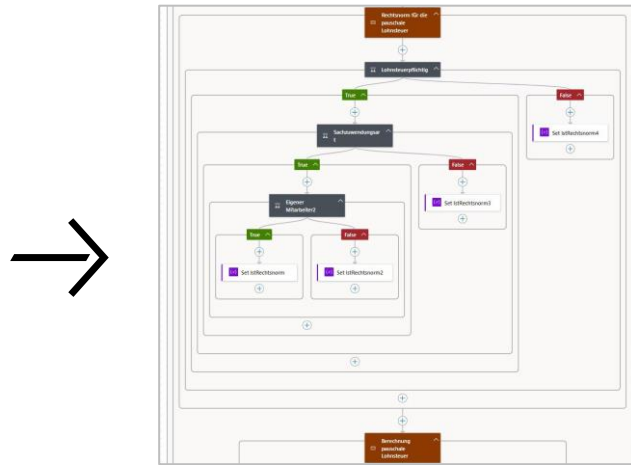

## 1. Data acquisition

All relevant content for the tax classification of benefits in kind is recorded using specialized Microsoft Forms questionnaires. There are different forms for gifts, hospitality and events.

## 2. Data processing

A submitted form triggers a Power Automate workflow that checks the content for **completeness** and **plausibility**, as well as **specifically** according to the **type of benefit in kind**. Decision trees in the workflow ensure that all benefits are correctly recognized.

A monthly concluding and **comprehensive review** ensures that tax advantages are optimally utilized and compliance regulations are adhered to.

### 3. Data results

**Masterfile:** enables continuous documentation of all benefits granted in a year. Additionally, a Power BI dashboard based on this provides important KPIs for management.

**Payroll Output:** monthly report as an import template for payroll accounting, which includes the taxable benefits at employee level.

**Accounting Output:** a monthly report that shows the necessary adjustments for the correct handling of VAT and CIT.



# Our technology

## Modular approach and decision trees

The BCT is modularly structured to meet the diverse requirements of different types of benefits in kind. It relies on our specialized forms for gifts, hospitality, and events and is completed by a comprehensive tax review based on decision trees.

### Decision trees in the workflow:

#### 1. Specific Reviews

Decision trees in the workflow ensure that gifts, hospitality and events are considered and handled correctly:

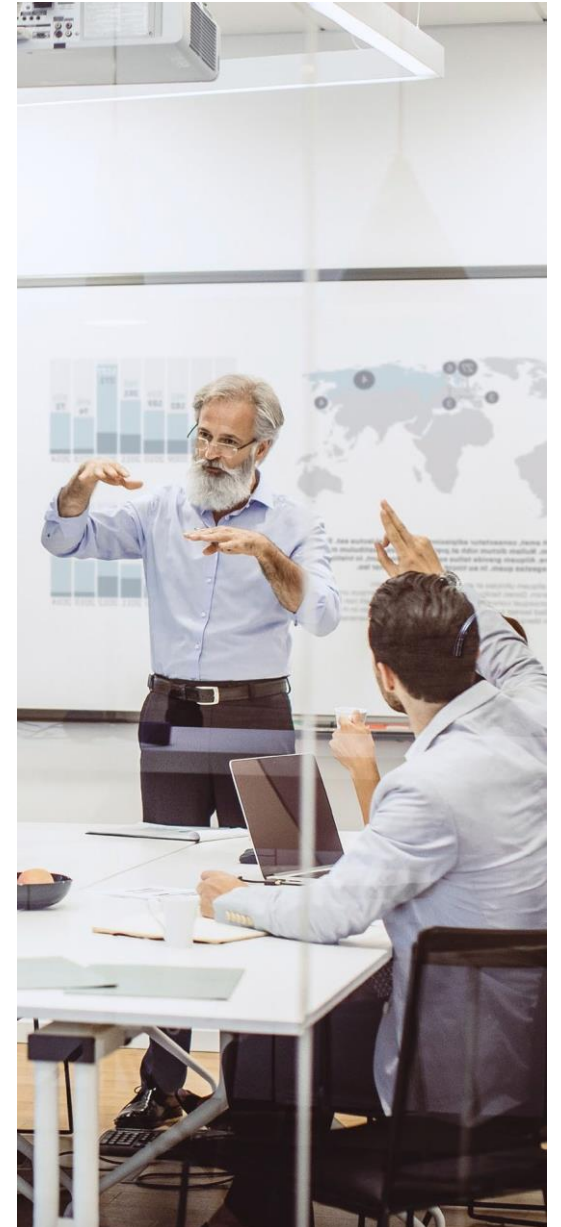
→ **Gifts:** Tax treatment of gifts to employees and third parties.

→ **Hospitality:** Determination of the tax treatment of entertainment expenses.

→ **Events:** Tax treatment of company events and other events.

#### 2. Comprehensive Reviews

In order to ensure a comprehensive and consistent tax review, the decision trees for the different modules are combined and audited for tax purposes. This cumulation enables a holistic view and assessment. This way, tax benefits that can be used regardless of the circumstances, such as the 50-euro exemption limit in accordance with Section 8 (2) sentence 11 EStG (German Income Tax Act), can be fully utilized. The comprehensive review ensures that all tax-relevant benefits and advantages are correctly recorded and evaluated in order to ensure compliance with legal requirements.

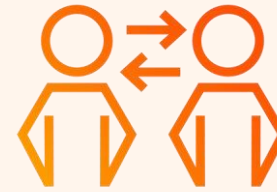
### Increased efficiency
